May 8: Get ready to vote on cdpACCESS on Group A 2021 code update proposals from Columbus

The Committee Action Hearings in Columbus, Ohio, are done and [online voting on Group A proposals](#) is expected to open May 8 for two weeks for those who were registered with their governmental units. International Code Council, ASME and the CSA Group chart a new course for plumbing standards

The International Code Council is working with the [American Society of Mechanical Engineers](#) (ASME) and the [CSA Group](#) to improve and streamline the development process for the A112 plumbing standards. The A112 standards regulate everything from water closets, showers, faucets, roof drains and grease interceptors to air gaps; and cover materials, fixtures, devices and equipment used or installed in plumbing or mechanical systems. The International Plumbing Code — the first model code published by the International Code Council in 1997 — references the A112 standards. [Click here to read more.](#)

The Technical Opinion Service for the International Codes is an exclusive benefit of ICC Membership. This service [provides prompt and reliable information](#) to assist in the [application of the ICC family of codes](#). ICC Membership types that receive this benefit fall into one of three basic categories:

- **Governmental Member** – Government/Municipality (includes agencies, departments & units) engaged in administration, formulation or enforcement of laws, regulations or ordinances relating to public health, safety and welfare. With this type of membership, any one that is an employee of the governmental member can use the service.
- **Corporate Member** – An organization such as an association, society, testing laboratory, institute, company, manufacturer or corporation, interested in the purposes and objectives of the Council. With this type of membership, any one that is an employee of the corporation can use the service.
- **Individual Member** – An individual who is interested in the purposes and objectives of the Council. Membership benefits are available to only the individual on the membership and cannot be used by anybody else. With this type of membership, only the individual that is the ICC Member can use the service.
