### High performance buildings and mitigation get the focus at the 2018 ICC Government Relations Forum

Officials from the State of Wisconsin and FEMA are among the keynote speakers at the ICC Government Relations Forum during the 2018 ICC Annual Conference in Richmond. It will be 8:30-11 a.m. Tuesday, October 23, in Room B15 C of the Greater Richmond Convention Center. Topics and speakers include:

- **Engaging code officials early in the process to achieve high performance buildings** - Henry Kosarzycki, Director, Office of Plan Review and Inspection, State of Wisconsin.
- **Mitigation investment of current building codes** – Angela R. Gladwell, Deputy Assistant Administrator for Risk Management, Federal Emergency Management Agency (FEMA).

Other topics include an update on ICC's new Military Families Career Path Program and the High School and College Technical Training Program. ICC Members will be eligible for ICC CEUs for attending. A speaker from HUD is expected to discuss recent federal regulations requiring the use of ICC-certified Residential Combination Inspectors (RCI) or Combination Inspectors (CI) inspectors for new construction as well as structural repairs and renovations of existing properties where the local jurisdiction does not provide building code enforcement and requisite documentation. Additionally, the **ICC Military Families Career Path Program will be the subject of a one-hour update** in Room B17 of the convention center starting at 1 p.m. Monday, October 22.

### **2018 Hurricane Season: ICC members are signing up for the Code Council's Disaster Response Network**

Now that Hurricane Florence has passed, our work is just beginning. Communities across North and South Carolina were severely affected by the storm, and the recovery process will surely be long and arduous for many. Code Council staff are in contact with the Federal Emergency Management Agency and will work with our members in those communities to help as needed. The 2018 code development process continues immediately after the ICC Annual Conference with the Public Comment Hearings which provide an opportunity for participants to influence the 2021 I-Codes. At the hearings, Governmental Member Voting Representatives vote on hundreds of proposed code changes on behalf of their respective jurisdictions.
